Associate Membership (all members are associate members)

Associate Member agrees to:

1. Pay an initial membership fee of **\$50**, renewable each January for **\$50**.
2. Follow the Westwind Rules and Regulations.
3. Respect the authority of the Barn Manager and cooperate fully.

Associate Members enjoy the following privileges:

1. Option to board two horses. See Boarding Agreement for more information.
2. Priority, after Los Altos Hills residents, for stalls or pasture spaces when vacancies occur. See Waiting List Agreement.
3. Vote in election of Board of Directors, and any other matter requiring vote of the general membership
4. Participate in Westwind events – shows, clinics, veterinary clinics, etc. To sponsor such an event, see the Barn Manager.
5. Buy hay or alfalfa at cooperative prices by prior arrangement.

Facility-Using Membership 4H/WRI-Facility-Using Membership

In addition to the above, Facility-Using Members agree to:

1. Pay in advance an annual use fee: **\$300** for individuals and **\$450** for families in which more than one member rides. Those joining after January pay at the rate of **\$25** or **\$35** per month for each remaining month of the year). For new members, the first month's use is included in the initial membership fee. 4H sponsors are exempt from the use fee.
2. Sign the Release of Liability.
3. Accept responsibility and ensure Westwind is reimbursed for any injuries or damage caused by you or your horse.
4. Take the annual Westwind Emergency Preparedness Tour by June 30 (or within 30 days of membership initiation). Those who fail to take the tour are assessed a monthly penalty of \$25 until they take the tour.

Facility-Using Members enjoy these additional privileges:

1. Use of the riding facilities at Westwind Barn. This does not include the use of the turn-out paddocks.
2. Take riding instruction on the premises from an approved instructor.
